The earnest money in the form of fixed deposit receipt, separately for each item/work, valid for a period of six months or more from any **Schedule bank only** drawn in favour of the Chief Office, Silvassa Municipal Council, Dadra and Nagar Haveli, Silvassa should be furnish to the undersigned during the office hours before the **issue date of blank tender documents** to the eligible contractor i.e. on or before dated **05/12/09** other wise the copy will not be issued. The Earnest money in separate seal cover marker "Earnest Money" should be submitted to the office of the Chief Officer, Silvassa Municipal Council during the office hours.

The Earnest money deposit **should not** be forwarded by **case / DD / Cheque**, otherwise the tender in the above manner will be summarily rejected. after last date of receipt of Tender form

The application and fees for issue of blank tender document forms to eligible contractors/suppliers will be accepted on all working days during office hours up to **05.12.2009** and the blank tender documents will be issued to the eligible contractors during this period **i.e. up to 15.00 hrs dtd. 05.12.2009.**

The tenders will be **opened on the 07.12.2009 at 16.00 hrs** if possible. The tender of the contractor/suppliers who does not deposit the EMD in the above manner will be summarily rejected.

The contractors should quoted rate in figure and word and total made without fail. The envelop of each tender should be superscribed "Tender for \_\_\_\_\_ (**name of item/work**) to be opened on dated **07.12.2009.**"
